## **Lilly Endowment** Continues to Help Us Shape Our Future with \$2-for-\$1 Match

Unity Foundation is one of 94 Indiana Community Foundations invited by the Lilly Endowment Inc. to apply for funding under **Phase VII of Lilly's GIFT initiative**. This generous program allows the Unity Foundation to apply for up to \$1 million to be used to strengthen La Porte County now and forever. Additional opportunities from the Endowment include the engagement of community foundation board members and community leadership grants, based on county population.

On October 15, Lilly Endowment announced a seventh phase of its **Giving Indiana Funds for Tomorrow (GIFT) Initiative** for Indiana Community Foundations. Begun 28 years ago, the GIFT initiative was designed to help local Indiana communities develop the philanthropic capacity to address their own needs and challenges.

"In the 28 years since GIFT began, community foundations have demonstrated their ability to inspire imagination, generosity and commitment among local residents, donors and volunteers. Changing economic and cultural dynamics are presenting both significant challenges and important opportunities for Indiana Communities. With GIFT VII, we seek to help community foundations raise resources and further enhance their ability to lead collaborative efforts to improve the quality of life for their residents."

The Unity board of directors will be evaluating all of these options. We'll announce those after we've carefully considered them. This is a tremendous opportunity."

Unity Foundation chose "Shaping the Future" as our theme. Looking back, we appreciate that the steps we took 26 years ago are paying off today. Because we took advantage of the Lilly Endowment's GIFT initiatives starting in 1991, we have created new infrastructure that makes it easy for anyone to leave a legacy. We have over 300 different permanent funds that will support all kinds of worthy causes...forever. We have helped thousands of our families pay for college. Unity has supported hundreds of our non-profits through our grants and endowment funds that will forever support them. And our leadership has helped the community respond better to opportunities and threats.

While we are pleased with our results over the past 26 years, we believe we can do more and do it better. We can do this by sharpening our strategic focus, partnerships, innovative technologies, and inclusive conversations. Recently our board of directors decided to focus on workforce development and education with the goal of increasing local incomes and family resiliency.

We are investing time, energy and funds into the La Porte County Skill UP Network. This unique partnership, with early support from our mayors and administrative support from the Center of Workforce Innovations, is working to bridge the gap between good jobs and people who want them, but need more skills. The Network received a \$677,000 grant from the Indiana Dept of Workforce Development and the goal is to build a talent pipeline - of adults and youth, benefitting our families and our employers. Unity is championing technology in our schools and partnering with others to "Skill Up" our residents for better paying jobs & careers.

Unity founded and supports the Home Team in its effort to coordinate services to prevent and respond to homelessness since 2004. We also founded and have supported the Trail Creek Watershed Partnership since 2003. Unity operates locally, yet in step with our regional partners. The Discovery Alliance (TDA) is an organization that joins together the community foundations in Lake, La Porte and Porter counties and brought in over \$18 million for education & literacy starting in 2000. Today that group helped fund Ignite the Region: NW Indiana's Strategy for Economic Transformation (NWIForum.org). These are all important steps taken years ago that are paying off.

As we look ahead, we are delighted to partner with the Lilly Endowment once again through GIFT VII. It promises to help us build our Power for Good Fund, which is most responsive to community needs. Lilly has added a community leadership aspect to this initiative, which includes funds for community planning and implementation. In their wisdom and generosity, they will help us take the next steps. It is these steps that will shape our future. There will be opportunities to join us in shaping the future and we hope to see and hear from you.

## Focus on Workforce Development, Education and Reducing Poverty

Each year, the Unity Foundation board of directors sets aside time for planning and reflection. This year Unity utilized the Healthcare Foundation of La Porte's information platform\* to create a survey for board and staff to evaluate community priorities. The results pointed to a focus on workforce development and education, with the goal of increasing local incomes and family resiliency. We are alarmed that the rate of children living in poverty in La Porte County is still **increasing**. It is only wishful thinking that the improved economy will reduce poverty for our families. People need more skills, youth need better pathways to living wage jobs and careers, and our employers need people skilled up for work in today's jobs.

Unity plans to increase our support of education and the La Porte County Skill UP Network goals. This new unique and collaborative partnership was started in 2018 with critical support from our mayors and leadership from the Center of Workforce Innovations along with the North West Indiana Workforce Board. It is working to bridge the gap between good jobs and people who want them...but need more skills. The Network received a **\$677,000** grant from the **Indiana Dept. of Workforce Development** with the prime goal of building a talent pipeline of adults and youth. The Network's focus is on training workers to fill plant maintenance positions quickly, increase awareness about manufacturing and technology careers, and increase our K-12 and Career & Tech Education student's exposure and credentials for manufacturing careers. If this is successful, the Network can add areas like healthcare, and other higher paying sectors. Matching funds for the Skill Up grant were needed, and **Unity pledged \$100,000 in** scholarship funds, making La Porte County's application more competitive.

Unity currently supports workforce development and education through our education grants, scholarships, and leadership. Unity is championing technology in our schools. We have gotten over 500 Ozobots into our schools to make coding fun for K-12 students and teachers. In 2017, we invested \$217,000 in college scholarships, \$140,000 in direct education support to public & parochial schools and teachers, \$311,649 in grants to agencies that provide, food, housing, health and human services for families in need.

We also tapped a dedicated volunteer, **Linda Wiltfong**, retired South Central Superintendent, to head up some of our education & workforce development projects. Her first task was to expand the **Week of Code** to all La Porte County public schools. Week of Code is a national event which takes place in December. Learning how to create computer codes is a critical job skill and helps students learn problem solving skills, teamwork and communication...all skills employers crave. Each school will decide how to participate. The La Porte County Public Library is a key partner and has a delightful array of classroom technology kits, supported by four fulltime educators. Lake Hills students work to program their Spehero to complete a maze during Week of Code.

#### CONTINUES TO HELP HOOSIER STUDENTS PURSUE HIGHER EDUCATION

The Unity Foundation is pleased to announce that two La Porte County students have been selected to be the 2018 Lilly Endowment Community Scholars representing La Porte County.

**Bailey Scott** from La Porte High School and **Jorden Clemens** from South Central High School will receive tuition to the Indiana colleges of their choice, and an annual \$900 stipend for required books and equipment. Both students had exemplary academic achievement, service to others, and extracurricular involvement. They were selected from amongst 74 outstanding applications received from throughout the county.

The Unity Foundation elects to participate in this program each year and manages the screening and interview process. Final review and decisions are made by the Independent Colleges of Indiana.



## Thomas Family Makes Immediate Impact

When Michigan City resident and former MCHS football coach, **Donnie Thomas**, passed away in May of 2017, his family knew they wanted to honor him in a way that reflected how he lived his life: supporting education and mentoring people to achieve their dreams. His wife, Peggy, instantly thought of creating a scholarship in his memory. The idea of annually honoring a qualified student with financial help for higher education seemed like the perfect fit.

While college scholarships are a great way to support continuing education in our community, it is not the only (or most effective) way to do so. After sitting down with the Unity team and sharing her goals for the fund, Peggy realized a once-a-year award would not reflect the magnitude of Donnie's impact on his community. Together, Peggy and her children Quinten and Kristen, decided to start a donor advised fund, and the Donnie & Peggy Thomas Empowerment Fund was born! Family and friends were encouraged to help grow the fund and make donations in Donnie's memory.

You can save a lot of headaches and make the most of your money by creating a will or estate plan. Unity has a new free tool that can help you! Just visit the **Planned Giving** resource on Unity's website (just "click the beach" on **www.uflc.net**) to learn more about how estate planning works. On the site, you can do one of three things:

- 1. Ask for a free Planning Guide
- 2. Sign up for the newsletter, or
- 3. Start creating your own plan!

(1 minute videos show you how to use the tool and prepare for your visit with your professional.)

You'll also find ideas for charitable planning that may save you tax dollars such as these:

- IRA Charitable Rollover persons age 70 ½ or older can rollover up to \$100,000 from their IRA to a qualified charity like ours. This can lower your income and taxes.
- **Outright Gift of an Asset** make a gift of stock, real estate or another asset, avoid paying capital gains tax on the transfer and receive a tax saving charitable deduction.
- **Donor Advised Fund (DAF)** – make a tax deductible gift to a DAF, which gives you the ability to make grants to your favorite charities this year and in future years.

## Home Team Advancing the Mission

The annual point in time count which measures the number of those without safe, stable shelter in our community has gone up in recent years and Unity is honored to work with those that are helping persons get housed and connected to needed services. Several Home Team partner agencies moved their mission forward in 2018. Each time we hear of an individual or family starting a new phase in their life – with a roof over their head – we are grateful for the opportunity to work with and facilitate collaboration between these important partners.

In 2018, due to the committed, impactful work by partner agencies and excellent facilitation of Home Team Coordinator Ed Seal, several occurrences helped to move the Home Team's agenda forward.

- Home Team representatives met with Lt. Governor Suzanne Crouch and Jacob Sipe, Executive Director of the Indiana Housing & Community Development Authority, in separate meetings, to share progress and highlight the goals of our Plan to End Homelessness. State Representative Jim Pressel and former State Representative Tom Dermody coordinated these opportunities to share the way La Porte County agencies are working together to address homelessness issues in our community. As Crouch noted in her subsequent social media post, the Home Team is focused and taking action.
- InterFaith PADS added a women's emergency shelter to their longstanding emergency men's shelter program this year, which is ensuring greater safety for women and children in need every single day.
- A new Home Team partner, We Connect, has brought an Employer Resource Network to our community - this was a much needed service that had been a focus for the Home Team agenda and we were excited when we learned that We Connect had been formed. They work with businesses to help employees maintain their jobs by connecting them to resources when they are in need. We Connect Director, Jackie Dermody, shares, "Too often, someone thinks they have to guit their job when a personal crisis occurs – we show them how to maintain employment while dealing with the issue in front of them. Staying employed and staying housed are critical to them working through the crisis...we connect people to resources to do just that."
- The Home team also obtained funding from the Healthcare Foundation

of La Porte in 2018 and were able to hire OrgCode Consulting to complete a shelter system evaluation, which was completed in September 2018. Shelter providers and Home Team members are using the results of the study to work together to implement recommendations.

Our fourteen year facilitation of the Home Team collaboration has experienced many successes, yet there is much work to be done. If you'd like to be connected to one of the partner agencies or be involved with the comprehensive support towards a solution, email **hometeamlp@gmail.com**.
