Community Funds help Unity Foundation provide grants to our ever-growing family of service-minded groups and individuals in the county. Each year, earnings from our Community Funds are pooled together and used to award Power for Good grants at our Annual Update Luncheon. These awards help support everything from environmental causes to arts education.


"Having adequate housing supplies can help make life less stressful and keep families together in a more pleasant atmosphere," said Marvin Larue, Manager of The Community Reserve. "In order to have a proper life, housing needs must be met."

Items, like furniture and kitchen utensils, are donated to The Community Reserve and stored in their CRIB (Community Reserve Inventory Barn). Since 2010, The Community Reserve has served over 700 families. And thanks to grants awarded from Unity's Community Funds programs like this will continue to reach out to those who need help in a time of crisis.

There's hardly a place in La Porte County that hasn't been touched by a grant made through a Community Fund, and it is people like the Rice family who help make that possible.
