

Romona Hay

Unity Foundation Board Member Former Unity Foundation board member, **Romona Hay**

(1927-2021) passed away on January 23, 2021. She served with Unity for 12 years from 1997 to 2009. Romona was especially passionate about education. She served on the general Scholarship Committee and helped launch the Lilly Endowment Community Scholarship committee for La Porte

County, which began in 1998. During her tenure, more than \$4 million in scholarship dollars helped lift students and their families toward a better future. Romona and her late husband, Dr. Gene Hay, were involved in many other volunteer and philanthropic organizations. They started the Hay Family Fund to benefit the people of La Porte County, now and forever.

As a board member, she helped the Unity Foundation grow to \$17 million in total assets. Romona shared her belief in the power of the Unity Foundation and the good it will do – forever. Our dear friend Romona was and will continue to be...a Power for Good.



Brett McNeal La Porte County Lilly Endowment Community Scholar

Brett McNeal (1985-2020) passed away unexpectedly on March 3, 2020 of natural causes. Brett was the first of our Lilly Endowment Community Scholars to leave us. We celebrate what was and grieve for what could've been.

He graduated from Michigan City High School in 2004 with

honors. He was section leader of the marching band, on the track team, in the National Honor Society, Vice President of the Spanish Club, Senior Class Representative to student government, and a delegate to Hoosier Boys State.

In 2004, he earned the Lilly Endowment Community Scholarship through the Unity Foundation. He was the first, and to date, only African American/Black male from La Porte County to win this honor and generous scholarship. He attended Butler University where he immediately became active in service organizations. During his junior year he received a grant that allowed him to study abroad in Hong Kong. In 2008, he graduated with a Bachelor of Arts degree – honors designation. He also served faithfully in the Youth Christian Education at New Hope Missionary Baptist Church in Michigan City.

Maggi Spartz recalled, "We were very proud of Brett and the way he grabbed on to life. He traveled, served others and kept on learning and making friends everywhere. He would share his activities with our staff with great enthusiasm. Brett was grateful to Unity for his scholarship. He was one of the Lilly's who would send a check periodically to 'pay it forward' to help others. This is a testament to his loving parents, Samara and Richard McNeal."

Washington Park Bandstand Restoration



Maggi Spartz, President, Unity Foundation of La Porte County Sarane Ross: Barker Welfare Foundation Director & President Emerita Susan DeMaio: Barker Welfare Foundation Executive Director & Assistant Secretary Shannon Eason: Michigan City Parks & Recreation Assistant Superintendent The Michigan City Parks & Recreation Department has launched a campaign to restore and preserve the Historic Washington Park Bandstand, an icon of Michigan City history. The Unity Foundation is supporting them by serving as a non-profit collection point for non-government fundraising dollars, through a fund created just to support our beautiful bandstand. Shannon Eason, Assistant Park Superintendent secured a \$100,000 grant from the Lake Michigan Coastal Program. This grant must be matched \$1 for \$1. Two organizations have already given or pledged matching funds; the Michigan City Historical Society for \$5,000 and the Barker Welfare Foundation for \$50,000, leaving \$45,000 yet to raise by mid-2022.

The original Bandstand, donated by John H. Barker in the 1890's was destroyed by fire in 1911. The current structure was designed by City Engineer H. M. Miles and dedicated on July 6, 1911. This Bandstand was the home of the Michigan City Municipal Band which played weekly summer concerts under its stately dome for 70 years until a new amphitheater was constructed in 1978. The old Bandstand was added to the National Register of Historic Places on June 26, 1991 and was the site for President Bill Clinton's visit in 1996.

In a report titled, *Washington Park 1911 Bandstand Preservation Project*, the renovation includes: replacement of the electrical system and lighting with LED technology, tuck pointing brick foundation walls, replacement of steel column roof bracing, painting and restoration of the stairway railing and more.

The Michigan City Parks and Recreation Department hopes the recent donations from the Barker Welfare Foundation and the Michigan City Historical Society will spark an interest by other community-minded people and organizations to donate and preserve this icon of Michigan City and La Porte County history—for the next 50 years. Vibrant Communities of La Porte County is a "once in a generation" opportunity to define our path forward. This community betterment effort continues to move full steam ahead as diverse stakeholders from throughout La Porte County work toward implementation of key items to enhance and strengthen our communities. While Unity Foundation and the La Porte County Convention & Visitors Bureau continue to lead the effort, it takes all of us to write and tell the story of La Porte County.

ALL BUILD

In 2019, community conversations identified the areas where we should focus our efforts first, identifying the issue of chronic lack of housing as a top priority. In 2021 we completed the first ever La Porte County Housing Analysis and Action Agenda in partnership with the La Porte County Office of Community & Economic Development. The "Welcome Home Task Force" that worked closely with Indianapolis-based consultant Greenstreet Ltd. to inform the study, brought county, city and town officialstogether and set a precedent for a new way of working together in La Porte County. The completion of the study is just the beginning. The Action Agenda called for us to establish and communicate a clear vision for housing growth, build a spectrum of housing to unlock growth, establish a housing trust fund, support commercial centers with dense, walkable housing, manage growth at the edge, and continue the conversation. Residents identified entrepreneurial support as another need, not just in our county, but throughout our Northwest Indiana region. Unity Foundation joined with Legacy Foundation, Crown Point **Community Foundation, Northwest** Indiana Small Business Development Center and the Center of Workforce Innovations to launch NWI BizHub in November 2020. The overall goal is to provide resources to build a better business. NWI BizHub connects entrepreneurs and small business owners to the right resources at the right time, no matter where they are in their journey of










ASSET GROWTH - ALL FUNDS \$ Million










