CELEBRATING UNITY'S 30 YEARS Honoring Mike Brennan, Unity Foundation of La Porte County Founder and Community Visionary



At an early age, **Michael Brennan** was admired by family and friends for his ability to get everyone together, get things done and make it fun. He grew up in a modest home

in the dunes of Lake Michigan and deepened his roots and love for community. Brennan attended Western Michigan University and then John Marshall Law School in Chicago and practiced law in Michigan City from 1967 to 1980. He was chairman for Tyler Refrigeration until it was sold in 1984.

His entrepreneurial spirit and risk taking- transformed Michigan City's Pullman Standard rail car manufacturing plant into one of the country's first outlet malls, built in 1987. Lighthouse Place was visionary and ahead of its time. The innovative and risky project on the north side breathed new life into Michigan City. Today millions of people come to shop there, giving people a reason to explore the area, a welcome mat for much needed new investment.

Lilly Endowment announced their innovative initiative called GIFT...Give Indiana Funds for Tomorrow in the early 1990's. Both La Porte and Michigan City were organizing their approach to Lilly when Lilly said, "If you don't work together, we're not going to give you any money!"

Thanks to Mike's connections, NIPSCO agreed to 'loan' Bob Schaefer as the first Executive Director of Unity Foundation to get organized. In September of 1992 the board hired Maggi Spartz full time to grow Unity and spread the word of philanthropy.

In 1992, at Historic Barker Hall, the board hosted a "kick off" dinner where they worked hard to get 80 people to attend. John Mutz, then president of the Lilly Endowment wrote: "We believe that the creation of the Unity foundation may be one of the most important events in the county's history."

In 1993, Brennan and his partners sold the outlet mall. They took \$500,000 from the sale and invested it in the Unity Foundation. This early generous gift helped Unity get a matching grant from Lilly Endowment, Inc. The partners could have done something else with it, but they decided to give back to the community - forever.

Through the vision and generosity of such a forward-thinking leader like Mike Brennan, and with other founders and donors, the Unity Foundation was established in 1992 as a one-stop shop, donor-driven community foundation that serves as a magnificent philanthropic vehicle as much for donors as for recipients.

Over the last 30 years, Unity Foundation of La Porte County has served donors, nonprofits and local communities. As La Porte County's community foundation, it manages over \$40 million in assets, administers more than 325 charitable funds, and has granted nearly \$23 million!

Our community owes a debt of gratitude to Mike Brennan as a Founder and driving force for the formation of Unity over 30 years ago. Mike's unselfish, strategic, and inclusive leadership has helped strengthen the communities of La Porte County now and forever.

30 INSPIRATIONAL YEARS \rightarrow A POWERFUL FUTURE

We celebrated our 30th anniversary in many ways. During the past 30 years we've been inspired by our donors, our teachers and scholarship students, our non-profit organizations and the people in our diverse communities. As an homage to all who've inspired us, we engaged in some special birthday activities:

- Increased our Power for Good grant pool to \$250,000, with a special allocation by our board. AND we increased our grant size from \$3,000 to \$5,000 per project. 91 projects received funding and cover a wide range of issues around youth, education, environment, health mental health, and more, impacting thousands of people.
- 2. In-person Gala: More than 300 diverse people attended our 30th Gala held on October 1st. We honored retiring founding board member, Mike Brennan for all his efforts to benefit the people of La Porte County through Unity plus his decades long history of creating jobs and putting Michigan City on the map. October 1st was deemed "Mike Brennan Day" by three entities, Michigan City, La Porte and La Porte County. We said we should all be more like Mike! (More on page 2.)
- 3. Helped 200 students and their families by awarding over \$330,000 in scholarships from 50 different funds. These grants of \$1,000 or more, decreased tuition bills, lifted families and increased levels of education and success. This year's recipients attended 52 different institutions across the U.S. and Canada. Since 1992, Unity has awarded more than \$3 million in scholarships, with many of these students returning here to live, work and raise their families.
- 4. La Porte County GIVES raises record dollars! Unity, with help from hundreds of donors and sponsors, raised at total of \$714,000 during La Porte County GIVES! 56 charitable funds participated, and benefited from \$370,000 they can use today AND by building their endowment funds at Unity for long term financial stability. 

Program seeks to increase the number of Indiana residents who hold college degrees. Unity Foundation of La Porte County recommends applicants to Independent Colleges of Indiana, which is funded by Lilly Endowment, Inc., to award full-tuition scholarships to outstanding La Porte County Students.

These scholarships will provide fulltuition, required fees, and a special allocation of up to \$900 per year for required books and equipment for four years of undergraduate study leading to a baccalaureate degree at any public or private college or university in Indiana accredited by the Higher Learning Commission of the North Central Association of Colleges and Schools.

The application period for the 2024 Lilly Endowment Community Scholarship Program opens August 9, 2023.

UNITY FOUNDATION TOPS \$714,000 DURING LA PORTE COUNTY GIVES

Unity Foundation of La Porte County raised a record-breaking total of over \$714,000 to benefit 56 charitable causes with endowed funds at the foundation as part of its **30th Anniversary** and **La Porte County Gives** event on Saturday, October 1, 2022. The 56 participating funds collectively raised more than \$370,000 during La Porte County Gives. An additional \$310,000 match pool was split among the causes in proportion to the amount they raised, and special prizes totaling \$31,000 were awarded.

Leading the pack was the La Porte County Symphony Orchestra raising more than \$90,000—a record for any one organization during a La Porte County Gives event. Family Advocates and Interfaith Community PADS rounded out the top three fundraisers.

The 30-hour online fundraising event culminated in a sold-out anniversary gala at Blue Chip. Past and present Unity Foundation Board Members, donors, non-profit leaders, young professionals, elected officials and community members came together to celebrate the special anniversary and be part of the record-breaking fundraising campaign.

Michael Brennan, Unity founder, board member and community visionary was honored for over 30 years of strategic and inclusive leadership. Congressman Frank Mrvan thanked Brennan for his service and presented him with a copy of a Congressional Record Statement, officially honoring Brennan for his inspirational leadership and wishing him well upon his retirement from the Unity board. Commissioner Sheila Matias, Mayor Tom Dermody and Mayor Duane Parry also honored Brennan during the event, declaring October 1 'Mike Brennan Day' in La Porte County and in the cities of La Porte and Michigan City. Unity Board Chair Jon Gilmore said, "It was Mike's vision and generosity that made Unity what it is today. You can't talk about Unity Foundation without Mike Brennan because we wouldn't be here without him."

Unity's African American Empowerment Fund offers a unique opportunity to identify challenges and opportunities to improve the economic and health conditions of the African American people in La Porte County.

Established in 2021 with \$100,000 in unrestricted funds by Unity's Board of Directors, the purpose of Unity's new African American Empowerment Fund is "to improve socioeconomic conditions and celebrate the contributions of African Americans in La Porte County." As part of Unity's 30th Anniversary celebration and record-breaking 2022 *La Porte County Gives* event, the fund placed 7th in raising an additional \$15,000 in two weeks.

The initial focus of the fund is on entrepreneurship and financial literacy and is championed by Denice Shipp-Glenn, Unity's Professional Volunteer.

The fund aims to help achieve the Vision for La Porte County: We envision La Porte County as a vibrant collection of unique communities that invest in their diverse people, grow their economic and health vitality, and promote innovative leadership through talented citizens for a rich quality of life for all.

Unity's African American Empowerment Fund is modeled after The Community Foundation of St. Joseph County's African American Community Fund, initiated over 20 years ago. This fund has inspired African American donors and funded projects including: Dolly Parton's Imagination Library; Programs featuring relevant authors; Bringing a life-size statue of Harriet Tubman to South Bend; and, many arts and culture projects of interest to African Americans. Unity continues to learn from and leverage such innovative projects.


